

## CLUB CANOE VALLEE DU CHER (AVENTURE CANOE) - COMMITMENT OF THE TENANT AND ITS GROUP :

I take responsibility for the persons accompanying me and affirm that they and I know how to swim more than 50 meters. I acknowledge that I use the equipment of the Club Canoe Kayak de la Vallée du Cher (Aventure Canoe) under my own responsibility and release the club in case of physical or material accident or incident. In the event of loss or damage to the equipment I agree to reimburse the amount indicated. (amounts posted at the club and on the website). I confirm that I am covered by a personal liability insurance for myself and my dependents (this insurance will be activated if an incident occurs). I confirm that I can swim at least 50 meters. I will be vigilant, wear life jackets, and appropriate clothing for the weather. I commit myself to disembark before each dam (disembarkation on the right bank by going down the river (dangerous site). Children under 6 years old are not accepted. Minors must be accompanied by at least one adult. Finally, I declare to respect all the instructions given in writing as well as verbally.

### Safety rules :

- No medical contraindications AND children under 6 years old not accepted - Know how to swim more than 50 meters / Wearing a life jacket is mandatory - Do not bring valuables, the cans are not guaranteed to be waterproof - Aventure Canoë is in no way responsible for any loss, breakage of the renter and the people accompanying him. The equipment rented by Aventure Canoë is for the use of the registered renter only, no subletting is possible.
- Respect the regulations in force: disembark upstream of each dam (on the right bank going down the river) and re-embark after the dam. It is forbidden to disembark in the park of the Chenonceaux castle and in certain private areas such as the island of the Moulin Fort upstream of the Chisseaux dam.
- Do not cross weirs, spillways, dams, waterfalls - Be vigilant when crossing bridges, be careful with arches: submerged branches...
- Practice self-safety: you navigate under your own responsibility and must help each other in case of capsizing - Prohibited alcohol - Provide water, snacks, sun protection, cap, sunglasses, clothing adapted to the weather conditions and the duration of the practice - Respect the surrounding fauna and flora - Around the Castle of Chenonceau, Chisseaux, and the beach of Montrichard, the non-motorized boats do not have priority: keep a maximum distance from the promenade boats and follow the banks when you cross them.
- Avoid getting stuck and stay alert to branches and trees along the banks (if you capsize and there is a lot of current, get on your back, feet facing downstream so as not to get stuck in the river bottom)

The rentals take effect as soon as the payment is made and the equipment is handed over to the tenant.

The average duration of the hikes are shown on our website and rates and are for information purposes only. No one will be able to ask for a compensation if his hike was done very quickly and in a hurry or by a group of an excellent level compared to the average of the groups.

We rent boats according to the number of people at the start according to the size and weight of the hikers. In fact, we reserve the right to adapt the number of boats according to the morphology of each participant. No one can impose the type of boat or the number of canoes without our agreement. Aventure Canoë cannot be held responsible for any accident or incident that may occur as a result of individual or group misconduct. No legal action may be taken against Aventure Canoë. All clients, hikers, agree to respect the time limits. If the time limit is exceeded by more than one hour, a supplement of 15 euros per person will be applied and invoiced upon arrival. Concerning the return shuttles, they are in priority for the repatriation of the drivers of the group of hikers. A deposit of 50% may be requested from the group and should be sent to the address indicated. The client may not denigrate Aventure Canoë, its staff or its employees without having had recourse to mediation with our structure. The customer may not denigrate Aventure Canoë, its staff or its employees without first seeking mediation with our structure. Any denigration, threats of any kind, intimidation, false opinions or ratings referring to the customer's desire to harm Aventure Canoë will be prosecuted.

The renter, as well as all the members of his/her group, undertakes to reimburse the water sports base for the amount of the lost or damaged equipment, including return costs: SINGLE PAGAIE: 25€ - DOUBLE PAGAIE: 35€ - GILET: 35€ - CANOE CANADIAN: 950€ - CANOE: 850€ - Hand trailer: 900€ - Canoe trailer: 1600€. The hirer and his group recognize to have subscribed a civil liability up to date.
